To support the manager in the leading of the Before and After School provision. To be responsible for the day-to-day organisation in the absence of the manager providing high standards of care and play opportunities for children between the ages of 4-11 years old in a safe and secure environment.

Main Duties and Responsibilities:

Delivering Before and After School Provision

- To support the manager and stand in when they are not available. To lead the day-to-day management and organisation of the Before and After School Club alongside the manager.
- To support, mentor, and coach a team of staff based at the Before and After School Club, planning and leading their activities.
- Work with all staff to encourage play opportunities and activities in a homely, nurturing, and safe environment, with regard to the individual development needs of the children.
- To oversee and motivate a team of staff to deliver high quality creative play opportunities in a safe and caring environment
- Liaise with the school with regard to the needs of the children who attend the club
- To ensure good liaison and communication lines with the Before & After School Manager and Playworkers
- To be a point of contact for parents
- To use knowledge gained as an NVQ 3 to lead best practice across before and after school club.

Management and Administration

- Act as the link between the school office and the before and after school club in the absence of the Manager
- Order necessary equipment and food when the manager is not available
- To be involved in the day-to-day administration and record keeping
- Monitor and evaluate the quality of the service alongside the Manager
- Maintaining working relationships with other site users
- To ensure that adequate standards of safety and hygiene are maintained throughout the before and after school club, including the completion of appropriate risk assessments and recording and reporting of hazards and accidents.
- To ensure food hygiene and allergen awareness procedures are adhered to
- To support the manager in ensuring that all staff work within the policies and guidance and procedures of the schools' policies

Staff

- To manage Playworkers alongside the manager and encourage best practice and development of play opportunities
- To be involved in professional development including participation in own appraisal, any necessary training and attending Before and After School Club Managers meetings to keep abreast of all current issues relating to providing wrap around care
